- 3. <u>Lisa Brassell</u> Representing Lake City Youth & Family and 100% Guadalupe; Reminder about Affordable Housing Plan; Last revised in 2015; Needs to be updated and implemented; Affects workforce and is a community wide issue; State Leadership will be addressing housing funding; Need to have a united front on this issue; Workforce Development CDL course forthcoming; Assessment must be completed; 12 slots are open; Round table session for food access forthcoming; Community has limited access to healthy food; Properties downtown and run-down buildings need to be cleaned up. Schedules of projects need to be published; GCDC is supposed to be part of the Housing Plan; Not sure if this is true.
- 4. <u>Mark Valenzuela</u> Only bond advisement agency in New Mexico; Represent several cities in New Mexico; Presentation handout was given to each Council Member; Explained process of services; General obligation bonds taxes; State's perspective City must invest in itself before they will give them money.
- 5. <u>Mark Cordova & John Paul Romero</u> Renovating Blue Hole restrooms currently; Close to completion; Looking at completion at the end of February; Looking at future projects with the City.

## G. DEPARTMENT REPORTS

- 1. Police Department Law Enforcement Classes coming to Santa Rosa; Proposed in June; Officer Astorga will attend Instructor Training in May; Utilizing Law Enforcement Protection Fund (LEPF) to upgrade equipment; New officer was lucky enough to find housing and moved here this week; 1 officer will be attending the academy in July; Revision of department policies will be completed soon; Councilwoman Blea commended Captain Pacheco on the progress and work being made within the department; Councilman Silva wanted to know if all of the equipment is working; Cameras and vehicles are being worked on; Tasers are being shipped; Working with the District Attorney with bringing cases; Please be patient with the department in this matter.
- 2. Fire Department 15 calls for January; Participated in High School Career Days; Prescribed burns conducted at Park Lake; Wildland Fire and Pump & Hose Operations training forthcoming; Need to order new hoses and turn out gear; Will work with Finance Department once quotes are received; Council asked if locks are cut for grass fires on properties, please make sure to replace them right away.
- 3. Community Development Route 66 Clean Up Thank you to all who participated; More grant opportunities are forthcoming; Will apply as soon as applications become available; Emergency funding was secure for the sewer project; Colleen from Stantec presented project updates for 5<sup>th</sup> Street, Smith Avenue, and Pecos Avenue; 5<sup>th</sup> Street Project is set to commence on March 10<sup>th</sup>; Main Street Project; Blue Hole Park Dog Park/Walking Trails; Barela Road MAP for design to construction; Dog Valley utilities (1 block); Chuck and Dale Area traffic study; Route 66 Centennial More funding in March; Working with the County; Prison is performing in-kind services during clean up events.
- 4. <u>Finance Department</u> Awaiting the approval of the Annual Financial Audit by State Auditor's Office; Quarterly Report was submitted on time; Monthly Check Report was included in the Council Packet.
- 5. <u>Senior Center</u> Annual audit was conducted on January 21<sup>st</sup>. We were advised of a few changes that need to be made in regard to the new policies involving labeling of products in the kitchen; Still looking for a trained tax preparer to help the senior citizens complete their taxes.
- 6. <u>Animal Control</u> 10 dogs were brought in the facility for the month of January; 9 dogs were returned to their owners; 1 dog is still awaiting to be transferred to a shelter; The new heating/cooling unit is installed and has been a huge improvement in keeping the kennels warm; The City was accepted in the Bissell Pet Foundation Partner for Pets Program; In 6 months, we will be eligible to apply for spay/neuter grants and participate in sweepstakes and contests.
