There is not a City Administrator; Revolving door in City; High employee turnover; High insurance payouts; Many terminations over the years; Please vote in favor of our community members; No confidence vote should be made against the Mayor.
- 6. <u>Ricky Chavez</u> Here on behalf of Guadalupe County; EMS Fund Act reversion of funds; Give balance to County as soon as possible; Letter mandating reversion was received by the City from the Department of Health EMS Bureau.
- 7. <u>Silver Chavez</u> Hear your community; Free country but yet hear we are; Dina has great ethics; Make a decision, but keep in mind, it will reflect in the next election; Council not doing good for Santa Rosa.
- 8. Fred Hinker Utilize the Library; Dina is very professional, kind and helpful.
- 9. <u>Ern Sanchez</u> Library experiences with son Noah; He has developmental disabilities and is employed at the Library; Dina has ethics and compassion towards Noah; Thanked the City for the continued support of his son.
- Max Tenorio Words on behalf of Dina; Wonderful at the Library; Wrote a book and gave a presentation Dina helped with this; Something is not right, please speak up; Due process needs to happen; Please reconsider her employment.
- 11. Janie Yearley Dina has always been there for me and my daughter; Car parts paid for and reimbursement was promised by the Mayor; Code of ethics should be followed; I cannot work since my car accident; Everyone is on the Mayor's timetable; Mayor leads people on.
- 12. <u>Mr. Marquez</u> Library support; Take kids and grandkids; Dina is one of the best Library Directors we have had; What is happening to her is very bad.

H. DEPARTMENT REPORTS

- <u>Police Department</u> Ongoing training; Finalizing Standard Operation Procedures (SOP) for Police Department; Weekly meetings with Lexipol for SOP; Stolen guns are an issue; Laws need to be updated; Catch and Release needs to end; Working with District Attorney's Office; Citizens of Santa Rosa and New Mexico need help; Working on an Ordinance for Off-Highway Vehicles; Hope to have it complete and approved before the summer.
- 2. <u>Fire Department</u> 9 calls for the month of February; Have been conducting prescribed burns; Staying prepared for the upcoming Fire Season; Have been watering Park Lake Field; Ongoing training for department.
- 3. <u>Community Development</u> Applying for multiple grants currently; EPA funds can start to be drawn down.
- 4. <u>Animal Control</u> For the month of February, 3 dogs came into the kennels; 2 were returned to their owners; 1 still needs to be transferred; Vaccination Clinic will take place on March 22, 2025; Looking for spay/neuter clinics for owned pets and feral cats; Animal Welfare Trust Fund passed the House floor; Going to Senate now; \$7 million for New Mexico; Animal Shelters benefit; Mountain lion attack update; Been aware of surroundings everywhere you go.
- 5. <u>Finance Department</u> EMS Fund Act FY2024 rollover was not approved by the Department of Health; This is the reason for the reversion of funds; Once reversion check is issued and all other EMS expenses are paid, the balance will be sent to the County.
- 6. <u>Senior Center</u> Public Hearings (Meetings) are forthcoming per a recent audit recommendation.
